This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene in any way (including by publication or distribution of any statements) in any political campaign on behalf of or in opposition to any candidate for public office. Without limiting the foregoing, it will be the intent of the corporation to emphasize the improvement of all aspects of education in the greater Delray Beach, Florida area.

No part of the net earnings or assets of the Corporation shall inure to the benefit or be distributable to any director, officer, member, or other private person, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Articles of Incorporation and these Bylaws.

**ARTICLE IX**  
**DISTRIBUTION OF ASSETS**


Amendments to these Articles of Incorporation may be made by a by a vote of three-quarters (3/4) of the Board of Directors where a quorum is present.
