Our Caps & Cribs Teen Mom Mentoring remains accredited through the National Quality Mentoring System by MENTOR, providing an evidence-based acknowledgment of the strong standards, safety and efficacy of the Caps & Cribs program. This program is a one-on-one mentor program that supports the educational, life, career and parenting goals of teen mothers in Palm Beach County. Volunteer mentors are matched with pregnant or parenting teens in high schools and provide guidance, inspiration and real-life experience in a trusting environment to empower teens to become independent, self-sufficient young mothers and to support the elimination of repeat pregnancies. During this fiscal year, the organization served 55 teen mothers through this program (an increase of 41%), 15 were seniors and graduated from high school. Circle of Moms, a maternal wellness program, is designed to support the one in seven women who will experience mood and anxiety disorders before, during and after pregnancy. Through peer-to-peer support groups, care coordination and training for health professionals, this program aims to bridge the gap in maternal mental health services in our community. This year, the Organization saw a 20% increase in the number of pregnant and postpartum women served through peer support groups and a 33% increase in the number of health professionals trained on perinatal mood and anxiety disorders. In early 2020, we became the only Share Pregnancy & Infant Loss Support Chapter in Palm Beach County, providing a resource for grieving parents and their loved ones who have experienced the tragic death of a baby through pregnancy loss, stillbirth, or in the first few months of life. Small Steps Great Parents is a free workshop series for pregnant and parenting families focused on topics like breastfeeding, newborn care, infant/child CPR, prenatal yoga and healthy eating. The program is designed to offer critical education to parents and caregivers and workshops are taught by trained Healthy Mothers, Healthy Babies staff, as well as partner agencies throughout the community. 67 classes were held this fiscal year with an added virtual component and served 678 participants, an increase of 57% from the previous fiscal year. Furthermore, a breastfeeding consultation program was added this fiscal year to serve lactation counseling needs of postpartum women. Additional program support at the Organization is used to focus on program development and enhancements, quality assurance, fund development efforts and other administrative needs to further the mission of the agency.

The Organization is the Prenatal Entry Agency for the Children's Services Council of Palm Beach County's Healthy Beginnings system of care. Through prenatal screening, assessment and linkage to services, the Organization supports clients in need of prenatal care access, health care navigation, medical payment source and other intensive social service needs to improve their birth outcome. This fiscal year, 10,163 pregnant women completed a Healthy Start Prenatal Risk Screen, a 61% increase from last year. Of these, 3,159 women received an individualized prenatal screening intake, a 25% increase from last year. Through a wide variety of programs, the Organization has touchpoints with more than 70% of women who deliver babies in Palm Beach County.

Form 990, Part III, Line 4b:

Centering Pregnancy is a unique, evidence-based model of client-centered group prenatal care that provides health assessment, education and social support. In 2020, the program was recognized by the Prenatal-to-3 Policy Impact Center at The University of Texas at Austin as a successful strategy to improve maternal and child health outcomes and is proven to nearly eliminate racial disparities in birth outcomes. 8 to 12 women with similar gestational ages meet as a group, receiving dedicated time with a medical provider and health facilitator to learn care skills, develop a support network and ensure access to prenatal care built upon trusted relationships. The program served 408 pregnant women, of the 194 who delivered, only 3% experienced preterm deliveries and just 3% delivered low birth weight babies.

Form 990, Part III, Line 4c:

As COVID-19 impacted our community, our Basics4Babies Emergency Pantry for Infants saw an intensive increase in performance outcomes. Serving children ages 0-3 with diapers, formula and baby food as its core distribution focus, the program experienced a 27% increase in children served, 57% increase in diaper distribution, 175% increase in baby food distribution and 203% increase in formula distribution. Overall, 26% of children served were new clients. In-Kind (non-cash) support of the pantry through diaper donations is reported at \$35,284.
