Each undertake very different activities but both work towards a common mission of changing the odds for children and families facing adversity. The Homeownership and Financial Capability division assists families to become self-sufficient by offering financial coaching, empowerment services, homebuyer education and coaching in order to achieve and maintain long-term home ownership and financial stability in all communities. These programs have assisted over 1,000 families to become homeowners since inception.
