Housing Services - The Homeownership Promotion and Preservation service area assists clients in fulfilling their dream of achieving home ownership, by facilitating access to a first mortgage loan, providing an 8-hour HUD certified homebuyer class and individual counseling sessions, identifying gap financing and serving as liaison among all parties contributing to closing the transaction. The Financial Capability provides clients with tools to build financial management, resilience and navigate daily finances. We provide a 3- hour financial fitness class and individual financial coaching sessions for clients to achieve and maintain long-term financial stability. Under the Financial Capability Program, we also provide Voluntary Income Tax Preparation (VITA) through a partnership with the United Way of Palm Beach County. We serve over 2,000 people under these two programs. Supportive Housing works with clients with a mental health diagnosis and/or substance abuse. We coordinate support services and link them to stable rental home through partnerships with private landlords or the local housing authorities. Additionally, we are a State of Florida licensed mortgage lender that provides down payment assistance as deferred/forgivable loans to first time buyers. More recently, we created our Real Estate Development and Asset Management program under Community Solutions where we will partner with other stakeholders and/or develop affordable housing and supportive housing units, whether new or rehabilitated in various neighborhoods.

The BRIDGES Initiative - Community Partners of South Florida (CP) operates six of the ten BRIDGES locations. The purpose of BRIDGES is to develop a coordinated and integrated, local system of care that is community-based and focused on healthy births, decreasing child abuse and neglect, and increasing school readiness. An aspirational goal is to ensure children are reading on grade level at the end of third grade. BRIDGES are gathering places that connect local families to community resources by drawing upon the strengths and resources of the neighborhood to heighten awareness about how families can support and keep their children healthy, safe and strong. Grounded in the principle that all parents want the very best for their children, families, and community, stakeholders collectively engage in the mission of ensuring the health and well-being of all children and families in the neighborhood at large. Funded by the Children's Services Council of Palm Beach County, the BRIDGES initiative facilitates family engagement and serves to strengthen and build community capacity and resilience by offering tips and workshops for parents, information on healthy ways to help children grow and learn, fun family events, connects members to community resources, and much more. BRIDGES initiative supports partnerships between organizations and residents of the communities to address and improve common social conditions that affect children and their families, with focus on community building and strengthening existing community assets. This year, CPSFL's six BRIDGES Hubs were able to support and impact over 1900 families. BRIDGES tagline is "Families Empowered. Communities Connected."

Mentoring Programs - Mentoring at CPSFL aims to link children with caring adults committed to their social and emotional development. Funded by the United Way of Palm Beach County through the Children's Services Council of PBC and The Youth Services of Palm Beach County, the goal of the mentoring program is to build protective factors, foster a sense of connectedness, and support the social-emotional learning through a supportive, positive adult mentor/mentee relationship. CPSFL operates four mentoring programs across the School District of Palm Beach County in high-need geographic locations: Pioneer Park Elementary in Belle Glade, Pahokee Elementary in Pahokee, Highland Elementary and Lake Worth Middle Schools in Lake Worth Beach. Participation in a nurturing, stable relationship with an adult in their life increases their protective factors and helps the youth reach their fullest potential. The goal is to provide mentees with an opportunity to develop a positive relationship that will impact their success at school, at home and decrease their risky behaviors while interacting positively with their peers and increase their social-emotional health. We facilitated over 140 mentor/child matches this year and made 43 new mentor-mentee matches this year alone.

Safe Kids - Every year, over 8,100 families nationally, lose a child because of a preventable injury When a child dies, the lives of families are changed forever Safe Kids Palm Beach County (SKPBC) is a member of Safe Kids Worldwide, a global network of organizations that work to prevent accidental injury, the leading killer of children 19 and under SKPBC is committed to reducing and preventing injuries to children in Palm Beach County, raising public awareness of preventable injuries, supporting public policy on child safety, distributing safety materials to families in need, providing safety education to parents, caregivers, and children Led by Community Partners of South Florida, and funded by Children Services Council of Palm Beach County, SKPBC hosts ongoing safety events and presentations throughout the year to provide parents and caregivers with the information and equipment they need to help keep children injury-free In 2019, SKPBC provided car seat education and installed over 1,400 child safety seats and provided 650 car seats to families in need Additionally, the team supported 539 presentations and community events to educate parents on life-saving information

Teen Outreach Program (TOP) - Our TOP program implements the nationally replicated, evidence-based Wyman's Teen Outreach Program (TOP) model. TOP is a comprehensive youth development strategy that promotes the positive development of adolescents through a combination of curriculum-guided discussion and community service learning. This youth development program, that uses a teen club model, helps teens develop healthy behaviors and life skills while giving the teen a sense of purpose. TOP has been proven to empower teens, so they can lead successful lives and help build strong communities. The program is designed to meet the developmental needs of middle (6th to 8th grades) and high school teens (9th to 12th grades) in a variety of settings, including in school, after-school, through community organizations or in systems and institutional settings. Curriculum topics include emotion management, problem solving, decision making, goalsetting, health and wellness, healthy decision making, self-understanding, social identity, empathy, communication, relationships and community (Wyman 2018). TOP has proven effective in increasing academic success and preventing teen pregnancy and other negative behaviors among program participants, while strengthening resiliency and building self-efficacy. The program provides teens with the necessary supports and opportunities to prepare for successful adulthood and avoid problem behaviors. TOP is funded by Children's Services Council of Palm Beach County. TOP retained 90% of their enrolled students for the school year. These 333 students completed a total of 10,202 group / individual hours of Community Service Learning.

Community Services and other accomplishments - Our community programs are rooted in our skill for identifying the strengths and talents that already exist within neighborhoods. We listen to residents as they tell us what is needed to maximize success in their communities. We identify and facilitate a neighborhood's own capacity to serve its residents and local youth. We bring the ability to identify and build new community partnership and enhance existing ones. CPSFL Community Services Area has expertise in Youth (School-Based) Programs, Parent Programs, Mentoring, Safety and Injury Prevention, and Placed Based Community Programs. In 2019, the programs of Community Services created impact countywide with over 21,000 volunteer hours.

Parent-Child Center, Inc. HPI and PCC share expenses for management and support services. Employees may work for one of the two organizations but provide services to both. As such, each organization reimburses the other for its proportionate share of resources used. During the year ended September 30, 2019, the net effect of these shared resources was a payment by PCC to HPI of \$866,400. Approximately \$23,380 was due from PCC at year end. Mortgage receivable from PCC for the Village for Change program, at an interest rate of 4.00% per annum, requiring monthly payments of principal and interest totaling \$1,691, collateralized by the property. The mortgage balance as of September 30, 2019 is \$26,539 and matures January 7, 2021. St. Charles Place Manor, Inc. HPI sponsored the creation of St. Charles Place Manor (St. Charles), funded through a HUD 811 grant. The HUD 811 grant required the sponsor to create a single-asset 501(c)(3) entity to administer the grant and to maintain the asset. The CEO of HPI is also the CEO of St. Charles, however its Board of Directors is different than that of HPI. HPI provided all financial, administrative, and operational services for St. Charles since its incorporation in March 2006. During the year ended September 30, 2019, St. Charles paid HPI approximately \$27,500 for management and supporting services. Approximately, \$12,300 is due at year end. In addition, as part of an advance for initial working capital, as required by the HUD 811 grant, St. Charles owed HPI \$30,000, as of September 30, 2019.</p>
