

On April 1, 2018, we launched our new Community Health Initiative to provide access to hygiene for unsheltered men, women, and children. We provide showers, laundry service, hygiene kits and clean clothing five days a week at the Coalition. In the first three months alone (to the end of the fiscal year) 374 unduplicated persons received 3,422 units of service. This service makes all the difference in helping folks maintain or regain employment, improving quality of life and reducing the spread of disease.
