OF THE TOTAL NUMBER OF CLIENTS SERVED, 26 PERCENT WERE NOT FUNDED THROUGH THE STATE CONTRACTS EITHER DUE TO NOT QUALIFYING FOR SERVICES THROUGH THE DIVISION OF BLIND SERVICES OR BECAUSE OF EXCEEDING THE NUMBERS OF CLIENTS WE ARE CONTRACTED TO SEE. IT IS THROUGH PRIVATE DONORS THAT WE ARE ALLOWED TO SERVICE THIS "UNFUNDED" GROUP. IN ADDITION, THE ORGANIZATION CONDUCTED 559 FREE VISION SCREENINGS FOR THE CHILDREN OF MARION COUNTY.
