FAMILIES MUST ALSO APPLY FOR FOOD STAMPS AND SUPPLEMENTAL FOOD PANTRIES ARE MAINTAINED ON ALL THREE CAMPUSES. FAMILIES ARE PERMITTED TO STAY IN THE PROGRAM UP TO 18 MONTHS BUT TYPICALLY EXIT OUR PROGRAM BETWEEN 6 TO 8 MONTHS.
