PRIMARY CARE SERVICES ARE CONDUCTED BY PAID PROVIDERS WHILE SPECIALTY SERVICES ARE DELIVERED BY VOLUNTEER PHYSICIANS. EVEN DURING THE PANDEMIC, 22 LICENSED HEALTH CARE PROVIDERS VOLUNTEERED 4,509 HOURS FOR AN IN-KIND DONATION OF \$829,493 WORTH OF CARE IN BOTH CLINICS.

THEY CAN RECEIVE HAIRCUTS, HAVE THEIR MAIL DELIVERED TO THE DAY RESOURCE CENTER AND GET ASSISTANCE WITH OBTAINING BIRTH CERTIFICATES AND LEGAL IDENTIFICATION. WE ALSO OFFER CLIENTS TRANSPORTATION ASSISTANCE, EITHER WITH BUS PASSES FOR THOSE WITH MEDICAL OR EMPLOYMENT APPOINTMENTS OR THE GIFT OF A BICYCLE. WHILE TAKING ADVANTAGE OF THE DAY RESOURCE CENTER SERVICES, CLIENTS ARE ALSO EXPOSED TO THE WIDE RANGE OF ADDITIONAL SERVICES AVAILABLE AT TURNING POINTS. THE GOAL IS TO CONNECT CLIENTS WITH THE SERVICES THEY REQUIRE SO THEY CAN BEGIN OR CONTINUE ON A PATH TO INDEPENDENCE AND STABILITY.

THE MAJOR GOAL OF OUR TDP PROGRAM IS TO ASSIST ELIGIBLE CLIENTS WITH RENT AND/OR UTILITY PAYMENTS TO PREVENT THEM FROM BECOMING HOMELESS.
