Furthermore, no interest or penalties have been included since no reserves were rec orded and no significant increases or decreases are expected to occur within the next 12 m onths. When applicable, such interest and penalties will be reported as income tax expense . Since tax matters are subject to some degree of uncertainty, there can be no assurance t hat the Organization's tax returns will not be challenged by the taxing authorities and th at the Organization will not be subject to additional tax, penalties, and interest as a re sult of such challenge. At December 31, 2019, the periods that remain open to examination under federal statute are for the years ended December 31, 2016 through 2018.</p>
