The President and CEO of HPI is also the President of the Organization. HPI is the management agent of the property and provides administrative services under an agreement in which it handles all financial, administrative, and operational matters for the Organization. During the year ended September 30, 2016 and 2017, the Organization paid HPI approximately \$32,508: \$12,630 for management and supporting services, \$14,378 salaries and benefits, and \$5,500 for repairs and maintenance expenses. Approximately \$2,300 is outstanding at year end and is reflected in accounts payable in the Statement of Financial Position. As of September 30, 2017, the Organization owed HPI \$30,000, as part of a working capital loan.
