St. Charles Place Manor HPI sponsored the creation of St. Charles Place Manor (St. Charles), funded through a HUD 811 grant. The HUD 811 grant required the sponsor to create a single-asset 501(c)(3) entity to administer the grant and to maintain the asset. The CEO of HPI is also the CEO of St. Charles, however its Board of Directors is different than that of HPI. HPI provided all financial, administrative, and operational services for St. Charles since its incorporation in March 2006. During the year ended September 30, 2018, St. Charles paid HPI approximately \$27,500 for management and supporting services. Approximately, \$2,300 is due at year end. In addition, as part of an advance for initial working capital, as required by the HUD 811 grant, St. Charles owed HPI \$30,000, as of September 30, 2018.</p>
