This pronouncement seeks to reduce the diversity in practice associated with certain aspects of measurement and recognition in accounting for income taxes. It prescribes a recognition threshold and measurement attribute for financial statement recognition and measurement of a tax position that an entity takes or expects to take in a tax return. An entity may only recognize or continue to recognize tax positions that meet a "more likely than not" threshold. The Society assesses its income tax positions based on management's evaluation of the facts, circumstances and information available at the reporting date. The Society uses the prescribed "more likely than not" threshold when making its assessment. At adoption, the Society did not record any cumulative effect adjustment, and the Society did not accrue any interest expense or penalties related to tax positions for the year ended September 30, 2018, and there are currently no open Federal or State tax years under audit.</p>
