See schedule O attached or most recent activities: In 2018-2019, 348 youth "Littles" facing adversity were matched with a volunteer "Big" in Big Brothers Big Sisters of Central Florida's Community and Site-Based programs. Those matches Littles achieved the following results: 100% refrained from dropping out of school, 100% of seniors dropped out of school, 74% improved their grades in school, 79% improved parental trust, and 97% felt socially accepted by peers.
