UWSK COORDINATES MANY DIRECT IMPACT SERVICES TO OUR COMMUNITIES. IN THE 2019/20 FISCAL YEAR A TOTAL OF \$83,812 WAS DISTRIBUTED TO HELP OFFSET THE IMPACT OF COVID-19 IN OUR COMMUNITIES. ADDITIONALLY, \$96,905 WAS INVESTED IN THE COMMUNITY FOR TRANSPORTATION AND OTHER GRANTS.
