Foothills Express operates a public deviated-fixed transportation route in Berea, Richmond, and Winchester throughout the week, riders are able to board the bus at any of the stops set up for only \$1. These stops include stores, apartment communities, city and county offices, and businesses. Wheelchair assisted door-to-door service is available for no additional cost and bulk passes are available at a discounted rate. The Madison Connector route operates through the week and links the cities of Berea and Richmond. After reaching their destination in either Berea or Richmond, riders are able to catch a ride on the city transit routes. Foothills Express also provides a commuter service from Winchester and Richmond to different locations in the Lexington area to assist employees in getting to their workplaces. Continuing to build on the long-standing partnership between Eastern Kentucky University and KRFDK, Foothills Express is the provider for campus transit services. Last FY transportation provided 210,751 trips.
