Once the families are referred, each family is assigned a case manager. The case manger is required to perform 30, 60, & 90 day evaluations of each family to monitor their progress in finding work and adapting to their new surroundings. The case managers also make sure that the funds each family receives has been spent to acquire good living and work conditions.

Part IV - Additional Information

Refugees and their families are the target for assistance from this organization. Individuals that are are referred to the organization are given food, clothing, furniture, and other household goods to get them started once they arrive here. Apartments are rented and rent is paid on their behalf by the organization. The Refugees do not receive cash until they have established a good track record of work and adapting, then they can qualify for employment bonuses. The organization also provides training to help Refugees adapt, such as teaching them the English language and other usefull skills to help them succeed.
