The mission of Growing Together Preschool is to provide affordable learning and developmental focused childcare services to infants, toddlers, and preschoolers. The nature of the services is educational and therapeutic with emphasis on inclusion.

**INFANT/TODDLER:**  
The infant and toddler program at Growing Together Preschool provides safe and nurturing care for children with and without disabilities year round. We maintain a low child to teacher ratio to ensure a high quality of care. In 2018 we served 87 infants and toddlers. Of those children 84% met their developmental and educational goals. Our teachers are trained to recognize developmental delays and know when to recommend early intervention services and they work cooperatively with a variety of therapists in the classroom. We have continued to partner with Early Head Start to provide additional services and resources for at-risk families. Growing Together Preschool provided tuition assistance to 7 toddler enabling them to attend the program.

**PRESCHOOL/PRE-K**  
The preschool and pre-kindergarten program at Growing Together Preschool provides a foundation for school and life readiness in an inclusive environment. The nurturing aspects of our care are further enhanced by greater social and emotional supports and behavior intervention. In 2018 we served 70 preschool and pre-kindergarten aged children. Of those children 82% met their developmental and educational goals and graduated from our program "ready" for kindergarten. Our teachers are trained to recognize developmental delays and behavior concerns. They know when to refer children for early intervention services and work cooperatively with therapists in the classroom. We have continued to partner with Head Start to provide additional services and resources for at-risk families. Our staff works with Child Find through the public school system to identify children in need of an IFSP before entering the public school system. Growing Together Preschool provided tuition assistance to 5 children enabling them to attend the program.

**FOOD PROGRAM**  
In 2018 Growing Together Preschool continued to be a leader in the KY Proud Farm to Preschool Program. We continue to find more opportunities to provide fresh, local food in our meal services and teach others about the process. We provide three well-rounded, nutritional meals to all children in the program daily. Children receive four out of the five recommended daily fruits and vegetables while in our care. We served a total of 69,673 meals throughout the year. Positive relationships with healthy food are promoted and reinforced by on-site gardens and gardening curriculum.
