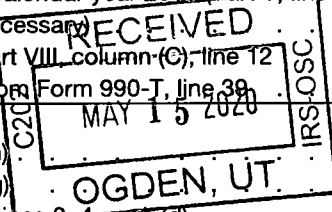

Case management is also provided for our clients to insure they receive all assistance available to them.

Provide assistance for extremely low income clients from the community not housed in the shelter, which includes help with food, baby items, cleaning supplies, and personal hygiene supplies. For those that are homeless, Simon House provides motel stays until alternative housing can be arranged. Case managers coordinate with other agencies to arrange for payment of utilities, rent, and security deposit.
