We conducted training for 310 individuals, 124 of which were virtual, which increases our impact at reduced costs. We increased our active partners from 17 to 22 and our active projects from 70 to 96. We continued our work in Ecuador with disaster relief efforts from the 2015 earthquake and were able to respond to the mudslide disaster in Colombia. Later in the year, WaterStep responded to the hurricane disaster in Puerto Rico by providing equipment and training for 78 disaster relief kits which provided safe water and proper sanitation in municipalities across the entire island.

As part of its process the Committee reviews compensation studies provided by Guidestar and similar organizations. Minutes to Executive Committee meetings are kept so as to substantiate deliberation and decisions.
