The East Knox Free Medical Clinic was established and began operating in May 2013. For years 2013 - 2017 revenue fell below \$50,00 and the 990 postcard was used for filing.

In 2018 a capital campaign produced revenue exceeding the \$50,000 threshold creating the 990 ez filing the clinic provides free medical care to the indigent community of East Knoxville and the surrounding area. the operation has expanded due to referrals from other local medical care facilities. During 2018, approximately 1900 individuals received medical care at no cost for services or medications.
