As a result of the relinquishment, the Agency reduced its staff by 178 employees, transferred fixed assets with a book value of \$469,149 to CDI, transferred three Head Start facility leases to CDI, and was reimbursed by CDI for the remaining seven Head Start Operating leases during the period of time CDI managed the Head Start grant. The Agency also disposed of Head Start vehicles that CDI did not accept for operations which had an approximate book value of \$29,415. After implementing processes to address the deficiencies identified by the Department of Human Services, the Agency reapplied and, effective August 1, 2020, was awarded the Head Start/Early Head Start grant for the 2020-2021 grant year. Property and equipment that was previously transferred to CDI was returned to the Agency after June 30, 2020.
