WE ALSO OFFER A HOLISTIC SET OF LIFE-SKILLS CLASSES, LIFE COACHING, AND REENTRY PROGRAMS TO PREPARE PRISONERS TO BE LEADERS IN THEIR COMMUNITIES - WHETHER INSIDE OR OUTSIDE OF PRISON. AS A RESULT, WE ARE SEEING PRISONERS USE THEIR SENTENCES AS A TIME TO GROW, CHANGE, AND FIND A NEW, POSITIVE LIFE PATH WITH PRISON FELLOWSHIP STAFF AND VOLUNTEERS AS THEIR GUIDES. EVERY CHRISTMAS, ANGEL TREE EQUIPS LOCAL CONGREGATIONS AND PARTNER ORGANIZATIONS TO MINISTER TO HUNDREDS OF THOUSANDS OF CHILDREN BY DELIVERING A GIFT AND THE GOSPEL MESSAGE ON BEHALF OF THEIR INCARCERATED PARENTS. IN ADDITION, MANY OF OUR PARTNER CHURCHES MEET THE PHYSICAL, EMOTIONAL, AND SPIRITUAL NEEDS OF PRISONERS' FAMILIES THROUGH YEAR-ROUND MINISTRIES SUCH AS CAMPING AND SPORTS CLINICS. THROUGH THESE PARTNERSHIPS, ANGEL TREE PROVIDES A PATHWAY FOR STRENGTHENING AND RESTORING PRISONERS' RELATIONSHIPS WITH THEIR CHILDREN AND FAMILIES. IN FY20, MORE THAN 159,000 PARENTS SUBMITTED APPLICATIONS, AND NEARLY 301,000 CHILDREN WERE ASSIGNED TO LOCAL ANGEL TREE PARTNERS WHO SERVE THEM. MORE THAN 6,000 CHILDREN OF PRISONERS ATTENDED CHRISTIAN SUMMER CAMP WITH A SCHOLARSHIP FROM ANGEL TREE. As the COVID-19 public health crisis brought prison closures across the nation, we continued to advocate for a more restorative criminal justice system, support second chances, and we developed new and innovative approaches to bringing the Good News of Jesus Christ into prisons and to support and strengthen families with an incarcerated parent. We pivoted from in-person programming to creative alternatives that included partnering with 20 departments of corrections to broadcast a recorded Easter celebration via closed-circuit television, hosting a Prison Fellowship Academy graduation via videoconference, and creating a Virtual Angel Tree™ option for delivering Christmas gifts to prisoners' children through the mail. We launched Floodlight™, our new online resource platform that makes available free encouraging and inspiring faith-based content for use on prison televisions and tablets. This response to COVID-19 prison closures is available in 307 facilities across 45 states, providing more than half a million incarcerated viewers safe access in their cells and dorms to this high-quality programming. We partnered with Kenny Dobbs, international Slam Dunk Champion and basketball instructor, to host a virtual Angel Tree basketball clinic. With premium filming optics and equipment, we filmed the 10 sessions in Phoenix, Arizona, at "The Phhacility," a premier basketball training complex. Along with basketball fundamentals and fitness drills, Kenny shared his story of leaving a life of crime, turning to Jesus and becoming a basketball superstar who speaks to children across the nation. As an expression of support and encouragement, we distributed to Angel Tree families 5,141 Caregiver Care Packages containing a \$150 grocery gift card, a One Hope Booklet, the choice of a basketball, football, volleyball, or soccer ball, and either a children's or adult Bible.
