SERVICES INCLUDE THERAPY, ADVOCACY, 24/7 HOTLINE, LEGAL ASSISTANCE, AND A 24/7 SAFE CLINIC THAT PROVIDES MEDICAL LEGAL RAPE EXAMS TO RAPE VICTIMS 16 YEARS OF AGE AND OLDER THROUGH A PARTNERSHIP WITH NASHVILLE GENERAL HOSPITAL AND LAW ENFORCEMENT.
