THROUGHOUT THE PANDEMIC, PROJECT RETURN REMAINED ON THE FRONTLINE AND CONTINUED DELIVERING OUR SIGNATURE SERVICES AND EMPLOYMENT OPPORTUNITIES. DURING THAT PERIOD, WE DEVELOPED ALTERNATIVE APPROACHES FOR OUR IN-REACH: WE CREATED VIRTUAL INSTRUCTIONAL SESSIONS FOR THE INCARCERATION FACILITIES THAT COULD ACCOMMODATE IT, WE MAINTAINED MAIL CORRESPONDENCE WITH ALL OF THE PRISONS AND JAILS, AND WE CREATED TARGETED PRINT CONTENT WHICH WE SENT REGULARLY TO THOSE FACILITIES FOR DISTRIBUTION TO THEIR RESIDENTS.
