 IDEAS exists to help resource-poor people around the world get the tools and skills they need to build secure & sustainable futur for themselves, their families, and communities. We do this by helping to improve non-profit organizations that provide very smal loans or other economic development services to poor people to start or expand small businesses. This improves low income communitiess. We provide training, technical assistance & innovative techniques and technologies.

4a (Code: WomenD) (Expenses \$ 75,306, including grants of \$) (Revenue \$)
 Over one third of Nicaraguan families suffer with "energy poverty" in this country that is the second poorest in the hemisphere. We continued to provide solar energy to low income farm families in fair trade coops and other communities that are off the electric grid. We continued to provide a non-profit microfranchise program called TecAp, which trains poor women to educate their neighbors. Using a unique non-profit education, we expanded to 8 different rural municipalities. In order to support the women involved in this non-profit social enterprise, we provide solar powered products to them. We train low income women microfranchisees to promote solar energy & teach poor households and community groups. The women distribute solar products that are very useful to the poor. We meet with the women in groups and individually in different communities, which are usually beyond paved roads. We teach them a variety of skills so that they can improve their livelihoods. The assistance to the women allows them to help the children and families & surrounding communities. They save money through renewable energy. We expanded our outreach in 2016. We educate Americans on the importance on assisting women on solar in developing countries. The women pass the benefits to their children and families. US foundations support this vital work with women who usually have less than a full elementary education. We trained more women about solar rooftop systems.

4b (Code: YouthTrai) (Expenses \$ 85,013 including grants of \$) (Revenue \$)
 In 2016, we held the 4th year of formal educational service to youth. We are training un^{der} and unemployed youth in low income communities that are off the grid (or just on the grid) to install and repair rooftop solar systems. We worked with non-profit group and local governments to recruit youth who had finished high school but do not have formal employment. We developed new aspects of the curriculum & tailor it further to the needs of unemployed and underemployed rural youths for practical technology. We gave the youth many practical experiences with installations and repair with low income families in many remote communities. Our graduates have an official diploma recognized countrywide. The training, material, food & lodging is free to the students. We graduated 26 more students in 2015 so combined with those graduates of 2013 & 2014, we now have 76 trained solar techs. In 2016, we provided a refresher course for the previous graduates. All provide local services not available otherwise. IDEAS works with graduate technicians to find campesinos who need rooftop systems and to install systems. IDEAS provides supervisors, parts, technical & logistical support to the youth so they can work & bring a new source of income to their poor families. IDEAS supported youth to repair systems on community centers, churches, and clinics. The program attracted support from 3 US foundations in 2016. IDEAS made alliances and did pilots in 2016.

4c (Code: Cap Bldg) (Expenses \$ 20150 including grants of \$) (Revenue \$)
 IDEAS continued its emphasis on capacity building of rural people, with a special emphasis on women and youth. We provide volunteer opportunities for US persons seeking further education and experience to be better prepared for work. Offered an independent study course supervised by the IDEAS Director and supported by Nicaraguan staff. The beneficiary was a male BA student who spent the year in 2016 doing documentation work to help youth and women. The Executive Director continued to bring his experience from Nicaragua & elsewhere to graduate students in the US. For the fifth year in a row, he offered, he offered 5 courses to grad students at Tulane U. He has offered education in other venues. We worked with various NGOs local governments that were seeking opportunities for high school graduates who have little opportunity of going to university. IDEAS assisted 2 women from low-income opportunities families to continue their professional education so as to bring eventually needed income and valuable service to their underserved communities. NGOs and municipal governments nominated youth for our educational programs. We have an agreement with a large NGO based at the Central American University to extend our services to the rural poor in coffee producing communities. We trained 16 members of their staff on renewable energy and they helped recruit youth and women for training. We provided mentoring and technical assistance.

Part VI, Section B, 15a & b: Yes, the determination of compensation did include a review and approval by the President & Vice President,

who are both volunteers and independent of the staff under review. These board members are non-profit professionals and are

knowledgeable of compensation levels in similar organizations. They did contemporaneous documentation of the deliberation and decision. Due to the low organizational income, it has not been able to pay a comparable compensation to that of other similar nonprofit

staff. The Board approves the budget that includes this but in recent years, the organization has not been able to pay the budgeted amt.

Part VI, Section C19: The organization can make those documents public upon written request to the Board, stating the reason for

the request and sent to the person listed on line 20. The Board President rapidly will make the decision and instruct the Executive

Director to provide the response.

Part XII, line 2b. The majority of the organization's work takes place in Nicaragua. The organization developed a Terms of Reference and

a committee selected an independent CPA to audit or thoroughly review of the organization's income, expenses and inventory in the

country. Similar to the 2014 audit, the books thoroughly examined in 2015 & were in accordance with Nicaraguan & international accounting standards. A bookkeeper in Esteli maintained the books and another in Managua thoroughly reviewed the records and put in

electronic form during 2015. Both the books in Nicaragua and the US are maintained in QuickBooks so that the third bookkeeper in the

US office is able to examine in Quickbooks. It is this information that is used to provide the information to the Board on a regular basis.

Also, this combined info from the two countries was used to inform the answers for this 990 and its schedules. The Board's Treasurer is

a Nicaraguan who is fluent in both Spanish and English so he is able to understand the financial information compiled in Nicaragua in

Spanish and local currency as well as the results in English and dollars. The whole Board reviews and approves financial statements at

each of its meetings. Thus, transparency and detailed oversight is maintained over all of the organization's resources and accounting.
