The board members are made aware that they are to report any potential conflict of interest of themselves and as well, any board member that they might suspect would have a potential conflict of interest.

04. CEO, executive director, top management comp (Part VI, line 15a)

CEO Executive director and top management salaries are approved at board level.

05. Other officer or key employee compensation (Part VI, line 15b)

There is only one paid employee and her salary is determined by the board.

06. Governing documents, etc, available to public (Part VI, line 19)
