THE BLOCK THE BLOCK IS THE LARGEST ADAPTIVE REUSE PROJECT IN CHATTANOOGA'S HISTORY, TUNING THE OLD BIJOU THEATER INTO A VIBRANT URBAN CENTERPIECE, INCLUDING ROCK/CREEK OUTFITTERS, STARBUCKS COFFEE AND HIGH POINT CLIMBING AND FITNESS, A 23,000 SQUARE FOOT STATE OF THE ART CLIMBING AND BOULDERING GYM WITH AN 11,000 SQUARE FOOT CLIMBING WALL ON THE BROAD STREET FACE OF THE BUILDING ITS PRIMARY PURPOSE
