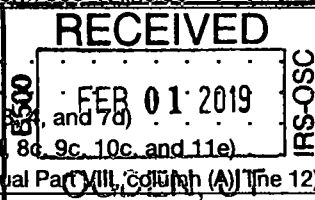

 In 2018 Montgomery County Veterans Transportation Service traveled 30,379 miles and transported 1,207 veterans and their dependents to and from hospitals, FREE OF CHARGE, in the Nashville/Murfreesboro, TN vicinity. This was accomplished using two 15 passenger vans, one having wheelchair capabilities. Many of our veterans are blind, unable to walk, need a cane or are in a wheelchair.
