The Montgomery County Veterans Transportation Service traveled 32,551 miles transporting 1,363 veterans and their dependents to and from local area hospitals free of charge. This is accomplished using two 15 passenger vans, one with wheelchair accessibility. Many of our veterans are blind, unable to walk, and/or require a wheelchair.

In 2019 we transported 1,363 veterans, donated 5,508 volunteer hours, and traveled 32,551 miles. This all volunteer organization consists of retire and military dependents. The majority of our veterans are disabled and completely dependent on our services.
