Neighborhood Organizing and Family Resource Center. The All About Women Health and Financial Stability grant provided a series of 7 forums for over 80 residents. They in turn, distributed the information to neighbors. The Fall and Spring Annual Community Health Fairs were attended by over 300 residents. The Crime Forum was attended by 87, and the Annual Night Out Against Crime by 300. We held Mother's & Father's Day celebrations. Partner agencies provided information booths. Over 700 residents attended. We had an Intergenerational Gardening program for our community garden. The community garden has 36 plots, 8 of which are raised beds, designated for senior participants. We paid 7 youth to work during 3 months, to help the seniors. The youth also maintained 3 plots for general community use. In addition, they helped with the garden plots of 2 summer camps for children.

Scholarship Program: Solicited contributions for college scholarships. Advertized the scholarships. Interviewed applicants. Awarded scholarships to 16 neighborhood students, who were mostly from economically challenged households.
