COMMUNITY SERVICES BLOCK GRANT PROGRAM (CSBG) PROVIDES A RANGE OF SERVICES AND ACTIVITIES TO ELIGIBLE LOW-INCOME INDIVIDUALS AND FAMILIES TO ACHIEVE SELF-SUFFICIENCY AND IMPROVE THE CONDITIONS OF THE COMMUNITIES IN WHICH THEY LIVE. CSGB PROVIDES INCOME TAX CONSULTING, HOME REPAIR/REHABILITATION, EMERGENCY SERVICES, NUTRITION, AS WELL AS CHORE SERVICE ASSISTANCE TO THE ELDERLY. THE COMMODITY FOOD PROGRAM DISTRIBUTES US DEPARTMENT OF AGRICULTURE SURPLUS FOODS TO QUALIFYING LOW INCOME HOUSEHOLDS FOUR TIMES EACH YEAR. A TYPICAL DISTRIBUTION PROVIDES 40-45 POUNDS OF FOOD TO A HOUSEHOLD AND MAY INCLUDE SUCH ITEMS AS RICE, BEANS, PEANUT BUTTER, SOUP, SPAGETTI, CANNED FRUITS AND VEGETABLES, POWERED MILK, NUTS, DRIED FRUITS, ETC. EMERGENCY ENERGY ASSISTANCE PROGRAMS PROVIDE AID TO HOUSEHOLDS THAT NEED HELP WITH THEIR UTILITIES. FUNDING SOURCES INCLUDE THE FEMA PROGRAM AND LOCAL UTILITY COMPANY PROGRAMS.</p>
