cannot be resolved in the meeting, the Director of Finance follows up on those
items with the tax preparer before filing.

Pt VI, Line 12c: Annually, Board members are requested to review and update
their status with regard to the Conflict of Interest Policy at a Board meeting.

In addition, the primary source of funding to the organization conducts an annual
review that includes review of compliance.

Pt VI, Line 15a: The Executive Director, compensated officers and key employees
receive compensation increases at the same rate as non-key employees. Pay increase
proposals are presented to the entire Board and approved during the approval
of the budget process.

Pt VI, Line 19: The organization makes its governing documents, Conflict of
Interest Policy, or financial statements available upon request.

Pt XII, Line 2c: The full Board approves the independent accountant and reviews
audit information.
