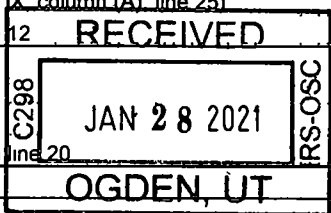
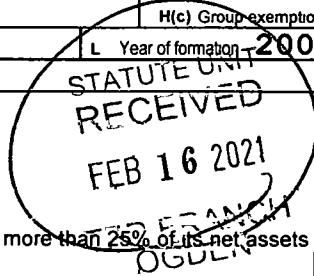

In Q4 2017, the former Executive Director exited the organization. Upon his exit he compensated himself approximately \$190K of which \$90K could not be recouped. Counsel has been retained to determine if the compensation paid can be back.
