Diaper Bank - An ongoing annual project initiated in 2019 to keep the infants and children of low-income families in Mobile and Baldwin Counties clean, dry, and healthy. During fiscal 2020, approximately 38,000 diaper were distributed through this community program.

Adopt A School Program - This program addresses the hunger and nutritional problems which occur with elementary school children during weekends and long holidays. This three year commitment to a local public school also provides clothing items such as socks, underwear, and belts to supplement the school's uniform and provides assistance in the maintenance and upkeep of the school's playground equipment.

Focus Areas - Our current five year focus area is Healthy Children, which is subdivided into the following three categories:

- Hunger
- Nutrition
- Fitness

This focus area provides volunteers and financial support for various projects which educate children about proper nourishment and maintaining appropriate levels of physical activity in order to maintain healthy lives.

Collectively, we annually invest over \$150,000 and more than 20,000 volunteer hours into these and other community based programs which impact the lives of over 18,000 men, women, and children.
