In 2017, the Community Food Bank of Central Alabama distributed 13,010,681 pounds of food to a network of 247 partner agencies in 12 counties of Central Alabama. The Community Food Bank and its network of partners provided charitable food assistance to between 52,928-71,845 residents per month. We also recovered 6,168,912 lbs. of food from 121 grocery stores, distribution centers and retailers, preventing this wholesome food from going to waste in local landfills. We also supplied weekend meal kits to 1,027 students, operated 3 mobile food pantries, launched 1 mobile grocery store, and supplied 8 school pantries that delivered fresh produce and healthy staples to the families of children in need.
