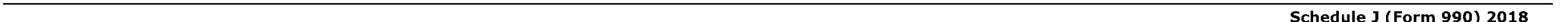

The 2017 amendments also made the following changes to the nature of the organization's board of directors: (1) to change the removal process for members of the Board of Directors whereby directors may be removed if there are vacancies on the Board of Directors, (2) to provide that the members of the Board of Directors would have staggered terms expiring on a certain date, and thereafter, would serve staggered 5-year terms, (3) clarified that the Jefferson County Housing Authority must approve of the new Board members in writing, and (4) clarified provisions for the appointment of members to the Board of Directors. The 2017 amendment added an additional provision to the governing documents that the Jefferson County Housing Authority could not unnecessarily delay, withhold, or deny any approval or authorization for actions otherwise permitted in the governing documents.</p>
