Other program services in the 2016-2017 school year included Birmingham Reads, Dolly Parton's Imagination Library, Ready 2 Read/Wise Words, Schoolwide Enrichment, Summer Learning, 30 A Day, and Academic Tutoring The Birmingham Reads event ensured 12,954 elementary-aged students in Birmingham City Schools had books in their home by providing a new book for every student in pre-k through fifth grade as well as providing 700 community volunteers who served as reading role models Dolly Parton's Imagination Library mailed 36,497 books to children birth to age five in areas of high poverty within Jefferson County A total of 3,758 children are building home libraries through this program In the Ready 2 Read and Wise Words programs, 2,250 second-grade students read books covering a wide range of interest areas from classroom libraries provided by Better Basics More than 703 volunteer hours were contributed by 128 community volunteers who encouraged students to read 33,775 books Schoolwide Enrichment gave 16,088 students in 34 schools the opportunity to benefit from a wide range of arts and cultural programming designed to enhance what is taught in the classroom by building vocabulary, inspiring imaginations, and broadening horizons Summer Learning worked with four community partners to provide engaging reading and math intervention to 112 at-risk students during a six-week summer program integrated into existing summer camps The 30 A Day program led 106 students in book clubs at four community partner locations in order to combat summer learning loss Academic Tutoring provided one-on-one tutoring in reading and mathematics at two locations in the Birmingham City area for students experiencing learning difficulties The goal of academic tutoring is to improve students' understanding about reading and mathematics concepts and help build students' confidence Across all programs, Better Basics reached 27,799 children and awarded 76,777 books to children, parents and teachers, with 1,107 community volunteers donating 7,766 hours of service

**Form 990, Part III, Line 4a:**

Better Basics operated three afterschool HOPE Centers at elementary schools in Fairfield, AL during the 2016-2017 school year. At the HOPE 21st Century Community Learning Centers, we are creating lasting change in the lives of our students, their families, and the community by delivering high-quality afterschool programming that focuses on enriching experiences that empower students to succeed. The HOPE Centers eliminate the disparity in access to academic enrichment that at-risk students often face. A caring and well-trained staff conducts daily activities designed to improve academic achievement in reading and math while encouraging the development of good character. In the 2016-2017 school year, 148 students participated in the program which operated every afternoon during the school year during the hours when students are most at risk (2:30 p.m. - 5:30 p.m.). On average, 66% of students made improvements in reading/language arts. In addition, HOPE participants had better rates of school day attendance than their peers.

---

## **Form 990, Part III, Line 4b:**

The Reading Intervention program is designed to help improve the reading skills and abilities of children who are performing below grade level. The program is comprised of two components: Small Group Intervention and Reading Mentors. Small Group Intervention serves students recommended by school faculty and identified by Better Basics staff as needing strategic, explicit reading instruction, with the goal of accelerating reading performance. Better Basics hires certified teachers to instruct selected students three times weekly for 20 weeks. Reading mentors serve children who are identified by school staff as needing reading support, but who are not able to be served in small group intervention. Volunteer reading mentors are trained to provide engaging, one-on-one reading experiences with their students with the goal of inspiring an enjoyment of, and an interest in, reading, while ultimately enhancing their independent reading abilities. In the 2016-2017 school year, 20 Reading Intervention teachers instructed 255 students in 11 elementary schools. More than 86% of students accelerated reading ability in our 20-week program. An additional 96 students were tutored by 92 volunteer reading mentors.

---

### **Form 990, Part III, Line 4c:**

The MORE program encourages fourth-grade students to read for pleasure by providing students access to a library of high-interest books. Children are encouraged to read 30 minutes per day from the library and are rewarded with books and other incentive prizes by volunteers who visit weekly to motivate students. Students complete book reports to improve and demonstrate reading comprehension and earn a book for every successful book report. Often, a MORE prize book is the first book a student has ever owned. In the 2016-2017 school year, 1,418 fourth-grade students in 62 classrooms across 20 schools were served in the Better Basics MORE program. Classroom volunteers reported that students read 15,920 books, and students and teachers received 20,687 prize and gift books. Through 2,542 hours of service, volunteers helped students become more confident readers while building their home libraries and a lifelong love for reading.
