The Keys to Kids Safety program helps save lives by educating parents and providing critical equipment to keep children safe. We ensured over 380 families were provided with necessary safety education and when necessary provided safety equipment such as 174 car seats, 70 toddler and child helmets, and 59 pack n play baby bed systems. Our team of 27 trained technicians found 84% of the 213 car seats checked throughout Monroe County to be installed incorrectly and parents were unaware they were not following proper safety recommendations.

The Healthy Start program continued to serve over 75% of families in Monroe County who welcomed new children this year. Services provided include care coordination, childbirth education, breastfeeding counseling, insurance application assistance, nutritional counseling, smoking cessation, parenting education, and interconceptional care. Last year we provided 17,362 services to 759 pregnant women and their families.

Form 990, Part III, Line 4b:

Healthy Babies (prenatal care) remains the only program in the County that provides subsidized prenatal care to uninsured and underinsured women. The Coalition is the payer of last resort for this necessary medical care service. Healthy Babies (mental health services) is the only program that provides pregnant women and postpartum mothers with a connection to specialized mental health practitioners that are extensively trained in Perinatal Mood and Anxiety Disorders. This year 16 parents received a total of 58 one-hour counseling sessions with our mental health professional, and 76 parents and 109 children ages 0-5 attended group sessions.

Form 990, Part III, Line 4c:

The Keys to Growing Kids program continues to expand. Our Tot Time program is county-wide and has grown to 7 playgroups a month. Though only launched last year, Wiggles and Giggles has grown to 6 monthly meetings in the Upper Keys. In 2020 the program will be brought to the Lower Keys. Tot Time is a fine motor skill play group giving parents time to interact with their children through song, healthy snacks, a craft, as well as time to meet one another and build their parenting network. Wiggles and Giggles is a gross motor skill play group encouraging families to move together through gymnastics, dance, yoga, and more. These groups empower parents as their child(ren)s first teachers and are often the only early childhood education opportunity for most families in attendance.
