The vision of All Faiths Food Bank (AFFB) is that there are no hungry people in our community AFFBs mission that we lead the community to end hunger, that we are the expert on hunger and nutrition education, that we are the hub of the hunger relief system, and that we see food as the beginning, the first step in a holistic response to meeting the needs of our hungry neighbors and helping them move toward independence AFFBs approach is evidence-based and data driven We focus on outcomes and impact and our work is measurable In 2015 63,000 people served 6.5 million meals provided 8.0 million pounds of food distributed 2.25 million pounds of fresh fruit and vegetables distributed More than 35,000 hours contributed by our volunteers in carrying out the mission of AFFB

Summer Hunger Program Recognizing that 21,000 children who are eligible to receive free or reduced meals during the school year may go hungry in our community during the summer months, AFFB initiated the Campaign against Summer Hunger in 2014 Continuing into 2015, the community-wide effort to raise awareness, food and funds was successful by raising more than \$1.2 million in funds and 1,000,000 pounds of food Programming occurred during the period of May 15, 2015 through September 30, 2015 This included 16 mobile pantry food distributions, close to 23,000 backpacks to children, 50,780 nutritious snacks, 118,600 pounds of fresh produce, and in collaboration with the County School District, more than 187,000 breakfasts and lunches to children in both Sarasota and DeSoto Counties In all, over 27,000 children received food during the summer programs as a result of a committed and engaged community programs as a result of a committed and engaged community

The Backpack Program provides a backpack full of nutritious food for students to take home so they will not go without food over the weekend and school holidays All Faiths Food Bank program staff work with school guidance counselors and teachers to identify children at risk and enroll them in the AFFB program Our program staff recruits and works with volunteers needed to pack the backpacks on a regular basis AFFB program and food distribution staff members work out all logistics of the program including the creation of healthy and nutritious menus, ordering of the food items, arranging the packing logistics and the delivering of the backpacks to the schools
