BACKPACK PROGRAM: ALL FAITHS FOOD BANK'S BACKPACK PROGRAM PROVIDES BAGS OF KID-FRIENDLY, HEALTHY FOOD TO STUDENTS ON FRIDAYS IN SARASOTA AND DESOTO COUNTIES. CHILDREN AT THE HIGHEST RISK OF GOING HUNGRY ARE IDENTIFIED BY PARENTS OR SCHOOL ADMINISTRATORS, AND RECEIVE FOOD TO TAKE HOME TO EAT OVER WEEKENDS AND HOLIDAYS. BACKPACK FOOD PROVIDES MEALS AND SNACKS FOR ONE CHILD FOR TWO DAYS. THE MENU WAS APPROVED BY THE UNIVERSITY OF FLORIDA FAMILY AND CONSUMER SCIENCES, AND ADHERES TO U.S.D.A. GUIDELINES.
