At Vita Nova Village, 85% of our residents completed secondary educational goals and 70% moved on to post-secondary enrollment. 75% are gainfully employed and understand how to create and live on a budget. All residents have assistance with education, employment, healthcare and therapeutic goals.

The SpotThe Spot is a safe and inclusive drop-in center for youth ages 18-24 at risk of or experiencing homelessness. The Spot provides connections to youth who are unaware of where to go or not sure how to get started, while linking them to resources and programming aimed at eliminating or reducing the risk of homelessness. At the Spot, youth may undergo intake and assessment, have basic needs met, receive life skills training, employment readiness training, educational support, and therapy from a licensed clinician. Youth will also receive linkages to meet housing, health care, nutrition, and overall wellness needs. Within the past year, the Spot has served 250 youth.

This pronouncement seeks to reduce the diversity in practice associated with certain aspects of measurement and recognition in accounting for income taxes. It prescribes a recognition threshold and measurement attribute for financial statement recognition and measurement of a tax position that an entity takes or expects to take in a tax return. An entity may only recognize or continue to recognize tax positions that meet a "more likely than not" threshold. The Organization assesses its income tax positions based on management's evaluation of the facts, circumstances, and information available at the reporting date. The Organization uses the prescribed more likely than not threshold when making its assessment. There are currently no open federal or state tax years under audit.</p>
