FOR THE FISCAL YEAR ENDING 6/30/21 THE CLINIC SERVED 1,103 UNDUPLICATED PATIENTS AND PROVIDED 3,925 ON-SITE CLINICAL ENCOUNTERS AND 329 APPOINTMENTS WITH COMMUNITY SPECIALTY PHYSICIANS. 352 NEW PATIENTS WERE ENROLLED. AMONG THE CLINIC ENCOUNTERS, 384 WERE PROVIDED THROUGH TELEHEALTH TO SUPPORT CONTINUING PATIENT CARE DURING THE COVID19 PANDEMIC. 95 REFERRALS TO OTHER COMMUNITY PROGRAMS AND 896 CANCER SCREENINGS WERE PERFORMED.
