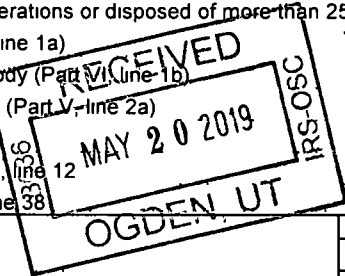

One of the challenges low income families face is providing their children with a stimulating and engaging summer day camp experience. HOPE Outreach Center provided 11 children with camp scholarships valued at \$6,032.00.

HOPE's Afterschool Children's program has provided opportunities for high school students to volunteer and was fortunate to have three siblings participate for three years consecutively. HOC nominated these young people as candidates for the annual Hands on Broward Youth Impact Awards. The family was selected and recognized at the awards ceremony in May 2018.

In addition to providing core services and programs, HOPE Outreach Center participated in several community outreach events designed to cultivate partnerships and expand the network of resources and referrals which can be provided to our clients.
