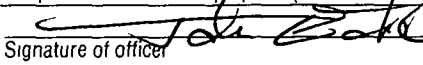
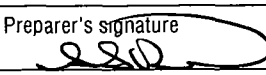

PREVENTION IS A COST-EFFECTIVE AND HUMANE STRATEGY FOR ADDRESSING HOMELESSNESS. DEPENDING ON THEIR LEVEL OF RISK, HOUSEHOLDS ARE OFFERED ONE-TIME FINANCIAL ASSISTANCE OR SHORT-TERM (THREE TO TWELVE MONTHS) INTENSIVE CASE MANAGEMENT SUPPORT IN COMBINATION WITH FINANCIAL ASSISTANCE WHILE THEY STABILIZE FINANCIALLY. DURING THE YEAR, 91% OF THOSE HELPED BY SHELTER, INC. WERE ABLE TO STAY OFF THE STREETS AND IN THEIR HOMES.

SHELTER, INC. TAKES HOMELESS FAMILIES AND INDIVIDUALS OFF THE STREETS, PLACES THEM IN SAFE, TEMPORARY HOMES AND PROVIDES SERVICES TO HELP THEM REGAIN SELF-SUFFICIENCY. SERVICES THAT ARE CRITICAL TO SUCCESS INCLUDE ONE-ON-ONE CASE MANAGEMENT, EMPLOYMENT SERVICES, EDUCATION, FINANCIAL EDUCATION, TUTORING, MENTAL HEALTH COUNSELING AND NUTRITION COUNSELING. DURING THE YEAR, 84% OF THOSE HELPED BY SHELTER, INC. MOVED TO PERMANENT HOUSING.

A TOTAL OF 1,492 MEN, WOMEN AND CHILDREN WERE HELPED DURING THE YEAR.

SHELTER, INC. OWNS AND MASTER LEASES APPROXIMATELY 200 UNITS THROUGHOUT CONTRA COSTA COUNTY, RENTING TO LOW-INCOME, VULNERABLE RESIDENTS, MANY OF WHOM HAVE OTHERWISE BEEN UNABLE TO FIND HOUSING. SHELTER, INC. CHARGES BELOW AVERAGE RENTS, WITH SOME TENANTS PAYING NO MORE THAN 30% OF THEIR INCOME TOWARDS RENT. A TOTAL OF 204 MEN, WOMEN AND CHILDREN WERE HELPED DURING THE YEAR.
