Communities Unlimited, Inc. was founded in 1975 to provide safe, clean drinking water and sanitary wastewater disposal to individuals in low-wealth rural communities first in Arkansas and then throughout a seven state region: AL, AR, LA, MS, OK, TN, and TX. Today CU is a community, economic development organization and a CDFI with approximately 50 full-time professionals providing intensive capacity building and capital to water and wastewater systems, entrepreneurs and communities throughout its region. CU's mission is to move rural and under-resourced communities in areas of persistent poverty in the South to sustainable prosperity.

**4 A. Community Environmental** - CU works with community environmental management systems including drinking water systems, wastewater systems, and solid waste management systems through on-site technical assistance and training, publications, and financing. CU supports efforts in under-resourced communities to provide access to safe drinking water for everyone and environmentally-responsible waste disposal within an ever-changing regulatory environment. As a regional partner of the national Rural Community Assistance Partnership (RCAP), CU provides these services throughout our seven-state region as well as supporting other RCAP regional partners with access to our CDFI environmental lending. For the fiscal year 2017, CU provided onsite assistance to 493 small communities and rural environmental systems serving more than 781,500 households and businesses. CU's environmental staff leveraged over \$54 million in construction financing to improve community water and wastewater systems in 45 communities serving more than 64,000 households. CU staff completed 65 formal training workshops attended by 794 community officials, board members, certified operators, and other environmental management system staff members.

**4 B. Access to Credit** - CU's mission focus areas drive our lending and allow us to provide financing to individuals, small businesses and communities that cannot access traditional capital. Understanding that success takes more than money, CU couples its lending products with technical assistance, education, and coaching to help borrowers succeed. In 2017 CU provided \$2.6 million in loans including \$2.4M to 22 rural water and wastewater systems to repair, upgrade, or expand water and wastewater services in rural communities; \$175K to help 9 small businesses grow successful businesses; \$100K to help individuals living in the Colonias and along the Texas-Mexico border repair and improve their homes. CU leverage and additional \$54M in loan capital primarily in improving access to clean and healthy water and wastewater systems in rural areas.

**4 C. Small Business Consulting & Community Sustainability**

**Small Business Consulting** - Management consulting services are provided on-site and virtually to businesses to help them solve problems so they can grow and contribute to the economic base of their communities. These services help new businesses start, grow existing businesses, transition businesses to the next generation, and turnaround struggling businesses. In 2017 management consultants provided technical assistance to 178 small businesses, 18 of which were new businesses, 41 new jobs were created, and 215 jobs were saved.

**Community Sustainability** focuses on building the capacity of diverse leadership teams in rural communities to build entrepreneurial ecosystems that foster the growth of existing small businesses and support entrepreneurs in launching new ventures. CU also coordinates value chains to connect assets in these rural places with real market demand in order to create new economic drivers as well as opportunities for entrepreneurs. The ultimate goal of all this work is to transition target communities from surviving to thriving.
