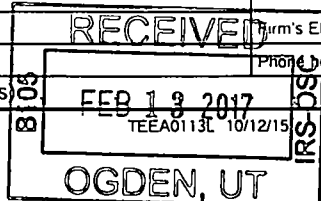

All governing documents, including the Form 990 are available to the public during regular working hours Monday through Friday.
