During our twenty-fourth year, Credit Counseling of Arkansas, Inc. (CCOA) concentrated on several critical components of organizational health. Our experienced team accomplished major operational and funding goals this year including passing accreditation audits conducted by Council on Accreditation, the Department of Justice, and the Department of Housing and Urban Development with no findings. Additionally, the CCOA team expanded to include three bilingual members fluent in Spanish and English. Thses new team members are helping our organization communicate with and serve our growing regional community more effectively. By aggresively pursuing our grant funding strategy CCOA maintained revenue from charitable donations at 30% of total revenue. Additionally CCOA grew the number of funding commitments and the number of funders this year. Finally our team was able to increase the number of strategic partners by five new institutions and the number of trained volunteers by 15.
