Our medical program is staffed by a nurse manager and 2 other nurses. We provide pregnancy tests and ultrasounds for women who are in unwanted pregnancies. Our Medical Program provided 431 pregnancy tests in 2017. We provided 551 ultrasounds for women in unwanted pregnancies and 113 chose life for their unborn babies. Those mothers were then provided parenting classes with new and used baby products to help them get off to a good start.

Our education program consists of Parenting, Sexual Integrity (Abstinence), Post-Abortion Recovery classes and the 24/7 Dad program and Life Coaching Career. A total of 604 individuals participated in our education classes in 2017. We also have a Relationship Building class and have seen several of our young married couples go through it and see the difference in their relationship getting stronger. This program is to help them deal with many of the issues that confront young married couples especially with an unplanned pregnancy. We disperse formula and diapers as well as clothes and maternity clothes to those in need. 2,000 students finished our Abstinence Program course this year.
