The YWCA Early Head Start program provides comprehensive educational and health services for pregnant adolescents, children of adolescent parents, young children living in poverty and their families. The program is first and foremost a child development program that enhances the development of children pregnant women on some form of public assistance and/or classified as homeless

SIHLE (Sisters Informing, Healing, Leading, and Empowering) works to guide teen girls (ages 13 to 19), as they strive toward personal dignity and future opportunity. This social skills training intervention intends to reduce sexual risk behavior for disadvantaged youth at high risk of becoming pregnant and contracting STDs, specifically HIV/AIDS. SIHLE teaches teen women to advocate for positive relationships with partners, by training in assertive communication, fostering positive social norms toward condom use, and empowering participants to negotiate abstinence and safe sex practices.

The Child and Adult Care Food Program is a type of United States federal assistance provided by the United States Department of Agriculture to states passed thru to local governments and nonprofit organizations in order to provide a daily subsidized food service for children, elderly or mentally or physically impaired adults in non-residential, day-care settings. It is a branch within the Policy and Program Development Division of the Child nutrition programs, along with the School Programs Branch, which runs the National School Lunch Program. The program is commonly referred to as the Child Care, Child Care Food, Adult Care, or Adult Care Food Program, and is often operating in conjunction with other child and adult day-care programs, such as the Head Start. Its federal identification number, or CFDA number, is 10.558. Section 17 of the National School Lunch Act, and USDA issues the program regulations under 7 CFR part 226.
