CASA volunteers focus on one child or sibling group at a time and represent the best interest of the child. Volunteer advocates offer Judges critical information to ensure each child's rights and needs are being attended to while in foster care. During the fiscal year 2016-2017, 287 children were served by 129 CASA volunteers through the Bureau and 21 new CASA volunteers were trained and sworn in.

There 463 clients assisted during the 2016-2017 fiscal year. Case managers oversee community service requirements and victim restitution where appropriate. Clients are supported through group classes that teach internet safety, law related education, anger management, and drivers improvement. Clients are further supported through parental training and referrals for counseling when appropriate.
